• Enforcement Actions (Craig Rogers)

The PUCN issued 10 in the south, 6th in the north. Trends – calling in a lot of tickets. Not an issue of multiple damages. More damages are going to occur if we don't start up NRCGA training again.

- CGA Best Practices and CGA Update (Cesar Castillo, Bob Ward) The CGA annual conference was rescheduled from March to October 12-15 at Sea World. In 2022, the annual conference will be April 12 - 14.
- USA North 811 Positive Response Program (James Wingate)
 - Ryan shared PR System Code Usage spreadsheet with participants. Trend Oct/Nov/Dec "Negotiated Markings Schedule" and "Unable to Locate Using Standard Locating Techniques" ticked upped in both CA and NV. A lot of members shifted from using other codes to those two codes. Positive response was used 588,000 times in 2020.

- The PUCN has opened docket 20-12029 to investigate making positive response mandatory in Nevada. Comments are due by Jan. 22. Dawn will email the notice out to NRCGA members so they know what's going on and where to send comments. The main driver of this docket is damage prevention. The PUCN wants to know that utilities showed up and that contractors are aware of marking status. Excavators can start digging before the mandated 2 days if they've gotten a positive response from all utilities. Positive response should be added to the NRCGA's training to make sure excavators are aware of it.
- USAN suggested hosting quarterly webinars with NRCGA members to get everybody prepped and ready to go on how to use PR.
