## 8. Best Practices (Craig Rogers)

The PUCN is waiting for mandatory positive response legislation to be signed. This has been in the works for 2 years. The 2023 legislative session will open soon. Craig will let us know when legislative workshops will be held. 2<sup>nd</sup> issue is new definition of excavation – NRS 455.

#### 9. Education/Training (Steve Wibalda, Nancy Lopez)

Dennis for Steve - Our training numbers were down in 2022 from 2021. We had a little over 1400 attendees in the south. In 2021 we had almost 2200 attendees.

Matt Brecke – Trainers in the north held 30 classes and trained 21 separate companies for a total of 415 individuals. Almost double what they did in 2021.

#### 10. Locate Rodeo (Dennis Bott)

The winner was Gregory Carreras. Gregory was present during the meeting and introduced himself. He's been a City of North Las Vegas locator since Nov. 2021 but has about 10 years of locating experience.

There were some challenges in planning the event at UNLV. All the people who had relationships with retired or moved on since Covid and we had to establish new relationships. Think of locations that might work for our 2023 rodeo and let Dennis Bott or Craig Rogers know. We're interested in locations outside of UNLV.
