STANDING ITEMS:

1. Introductions (Dennis Bott)

Dennis led introductions.

2. Adoption of the Agenda (Dennis Bott)

Motion made by Scott Allen; Jethro seconded. No vote against. Motion passed.

3. Financial Status Report (Dawn Rivard)

- Balance at \$69,437
- 2023 due invoices will be sent this month
- Finance Committee will meet before January
- Reminder to attendees, if organization is not a paying NRCGA member, you cannot be part of committees.

4. Enforcement Actions (Craig Rogers)

- Seven civil penalties: two operators; five excavators.
- Due to a recent Five Million Dollar Connecticut penalty for a fiber install that caused multiple
 damages, NRCGA goal is to be prepared for the local area's anticipated incoming fiber project. The
 ultimate objective is to be properly staffed to maintain Nevada's current two-day locating target.
 Craig Rogers and Dennis Bott have discussions scheduled with the (undisclosed) fiber company, to
 request as much notice as possible in light of the time necessary to train locators.

5. CGA Best Practices and CGA Update (Craig Rogers)

- The recent CGA summit focused on the following three challenges: Facilities not accurately marked and late; excavator errors; and effective and consistent use of 811. Each Committee should focus on ways to help work towards addressing each challenge.
- Gold shovel organization will merge with CGA in January. If a member of the Gold Shovel, you will
 automatically be part of CGA DPI (or Damage Prevention Institute). DPI will organize two
 committees: pre-construction and construction. If your company is a Gold Shovel member, you
 will be accredited. More information is on website.
 - 1. Review of Chapter 3 One Call Center. 811 Call Center will also provide an 800#.
 - 2. Review potholing and best practices. Task team how to pothole properly. Language being adjusted 202201 for excavators.
 - 3. Excavator role in positive 202206 response. 30-day posting language is changing to ensure operators are providing a positive response.
 - 4. 202202 Abandoned lines. Pilot w/ Texas 811 and operators.
 - 5. 202203 Disastrous response and recovery. Task team set but no proposal
 - 6. Active groups working to submit TR Subsurfacing; Design and planning How-To's. Interested in Subsurfacing utility? Second working group: ticket life and preservation of marks. Bilingual efforts. Ticket load leveling and scheduling. NRCGA is interested. Mapping. And 6: trouble locating. Task team modeling how to handle trouble locates.

NEW BUSINESS:

6. New Member – GPRS, Inc. (Dennis Bott)

- GPRS is 100% focused on damage prevention and has been an active participant with CGA and wishes to continue its involvement.
- GPRS has several pilot programs used to help excavators. With their roughly 10,000 projects per year, ranging from small utility locates to larger, campus-size areas, each considered one project, they share knowledge with their clients that include environmental companies, general construction, telecom companies, etc.
- Plan and Design tickets in Nevada have been a focus so the NRCGA is excited to have GPRS as an actively involved member.

COMMITTEE REPORTS:

7. Best Practices (Craig Rogers)

- Definition of excavation (moving from mechanical to hand tools). Excavating over 12 inches even
 with hand tools needs a ticket. Recommended Members attend the January workshop (specific
 date TBD). Workshop will answer questions and discuss revisions to determine if NRCGA will
 support this law, which must have 100% support.
- Mapping petition to reclassify USAN as a State Agency to allow State of Nevada to provide mapping data. This adjustment, limited to maps only, is for excavator use.



8. Golf Tournament (Bob Ward)

- For first year, event was a huge success. A few recommendations for next year: new venue; change to Friday; earlier in year (warmer).
- \$13,962.99 in revenue. Helped offset costs of other NRCGA events.
- SWG team first place. Photos on NRCGA website
- Bob Ward will chair the 2023 event

9. Education/Training (Steve Wibalda, Matt Brecke, Nancy Lopez)

- Seventy different companies 1,325 attendees
- Course is free and registration is easy. Offering four classes per month (two Spanish two English)
- Reminder for Members: send your people or promote the class.

10. Locate Rodeo (Dennis Bott)

- Opportunity to acknowledge those locators who have gone a full year without any issues.
- Will be at UNLV December 17th.
- To date, approximately thirty (30) competitors registered.
- Need volunteers for time keeping, wheel judges, etc.

12. NUCA Damage Prevention Committee (Harold Lefler)

- Private utilities marked; looking to improve the process (ticket size, ticket duration, assignments).
 On time percentage markings for some entities and those who needed improvement were receptive. One problem from excavators: dig tickets come back "white paint unclear" but pictures show clear.
- NUCA and NCA electronic positive response...maybe adding some codes to State of Nevada.

13. USA North 811 NV Committee Update (Boyd Duchene, Bob Ward, Dennis Bott)

- Two weekly webinars are available until the Pelican cutover of December 16th. The first webinar was attended by 370 participants.
- December 12th is early access for excavators
- Existing tickets won't be moved over, but will still be active.
