2. **Adoption of the Agenda (Cesar Castillo)**

3. **Financial Status Report (Dawn Rivard)**

4. **Enforcement Actions (Craig Rogers)**

The PUCN issued two enforcement actions against operators and two against excavators. Three were in north, one in south. Those who have received enforcement actions this past quarter are new to Nevada, which could be the reason why they committed damages. They're not used to NV laws.

Google fiber is coming to town. We don't know what kind of affect the subcontractors Google hires will have on damages. We'd like the subcontractors to go through the NRCGA training program so they will know NV's expectations. They can install 1000 feet of fiber a day. They can be in and out of a neighborhood in 5 days. We need to set up a meeting with stakeholders and Google prior to Google's arrival. We'll have a meeting in the north and the south.

It appears government funding/grants is pushing this fiber work around the country. Government is working to provide money to install fiber in "underserved" communities, like in NV rural areas. A lot of times "cowboy" excavators come to town from out of state, do the job, don't care about the law or damaging others' facilities. Google installs fiber in other utilities trenches/rights of way.

6. **Lynsay Demko to Replace Dennis Bott as NRCGA Director**

Board voted in Lynsay Demko, damage administrator with SWG, as the gas stakeholder. She has taken over Dennis' position. She's been with SWG for six months, but has 6 years of experience in damage prevention with another company.

**COMMITTEE REPORTS:**

7. **Excavator Appreciation Dinner/Silver Shovel (Cesar Castillo)**

The event is planned for April 26, from 5 to 8 p.m., at Stoney's Rockin' Country at Town Square. The Silver Shovel candidates have been selected and the winner will be announced at the event. NUCA will help spread the word and USAN will add a message to all NV excavators requesting a dig ticket through their Pelican system.

Pelican Ticket Software: USAN is past the big hurdles with the software changeover. Ticket sharing is coming and will be available soon. Expired ticket filter for history tab will also be available soon.

AB 177: this bill would authorize counties to share GIS data with USAN. Pelican uses Google maps, which is great, except for in new subdivisions, which is where much of the excavation occurs. With access to county GIS data, USAN will be able to add a layer over google maps with Clark County GISMO data, including new parcels. Not sure what will happen with Washoe and other counties up north. Just this morning at the Legislature, NVE, SWG, Google Fiber, Las Vegas Paving testified in support of this bill. It passed the assembly unanimously and will move on in the process to becoming law. There are five steps and it's passed the first step.

Design Tickets: USAN will have a test version of a design ticket platform in the next few weeks. One-Call Access – the design ticket platform will work just like one-call access. The new DT platform with Pelican, USAN will have the ability to deliver these to engineering departments at utilities for review. USAN hasn't heard from NV utility operators about design tickets, only excavators. This feature will stop people from submitting 811 tickets when they're really looking for design tickets.
