STANDING ITEMS:

1. Introductions (Cesar Castillo)

Introductions took place.



2. Adoption of the Agenda (Cesar Castillo)

Sal Caponigro made a motion to adopt the agenda. Harold Lefler seconded the motion.

3. Financial Status Report (Dawn Rivard)

Dawn provided a financial report.

4. Enforcement Actions (Craig Rogers)

In the last couple months – 2 civil penalties, one to a utility and one to an excavator. One letter went out to a utility. They have 30 days to reply. Don't know how that letter will resolve – penalty or not.

- **Senate Bill 27 – Definition of excavation changed**
It feels like it's maintaining about the same level of ticket requests. Mark Marrero hasn't seen much of a different. We have to monitor landscapers- they weren't calling for tickets before. They were afraid of the impact on the 811 system. Craig thinks most people were already calling in tickets for hand digs.

5. CGA Best Practices and CGA Update (Lynsay Demko)

Language for a potential best practice for trouble locates is being circulated now. It'll be up for vote soon to determine if it'll be adopted as an official CGA best practice or not. The CGA's Summer Committee Summit will take place in Gulf Shores, AL, July 31-Aug. 3. Great opportunity for networking, etc.

6. USA North 811 Update (Ryan White)

A couple new Pelican fixes coming. In August, self-service planning and design platform should be ready. For the design platform, during the design phase, you can log into Pelican, draw out your design area, and you'll get a list of utility contacts for utilities that are in your design area. Pelican will transmit your request directly to the utilities' engineering department. These aren't dig tickets. They'll have a completely different number from a dig ticket.

USA North's next board meeting is Wednesday, July 26.

- **Assembly Bill 177 – Authorizes Nevada counties to share GIS data with USA North 811**
James Wingate spoke about the passage of AB177. It passed unanimously through both the Assembly and Senate and was signed by the Governor. Its effective date Oct. 1, 2023. The guy who held the position of NV State Demographer, who keeps track of stats for the state, left his position in March. His position is posted, but not filled yet. James will go to this position's supervisor to make sure this law doesn't fall through the cracks during the transition. AB177 allows counties to share data with USA North. Southwest Gas lobbyists were very helpful in getting this bill passed and testified in favor of it. NV Energy testified in support as well. Las Vegas Paving and NUCA provided support. Thank you to everyone in the damage prevention community for helping to get this bill passed. It'll help in getting more accurate tickets to locators and excavators. "It's a win all the way across the board." USAN used to have to buy data from data vendors. They will save 10s of thousands of dollars now that counties have to share their plot data.
