STANDING ITEMS:

1. Introductions (Cesar Castillo)

Cesar Castillo started the meeting with an introduction.

2. Adoption of the Agenda (Cesar Castillo)

The agenda was adopted.

- **Underground Service Alert (USA North 811) Update (Ryan White)**

James Wingate, Executive Director: Nevada had over 200,000 tickets in 2023 for the 1st time since 2006. James will forward USA North's annual report to Dawn to distribute to everyone.

- Colin Miyadi: USA North has added a new hire to the marketing team. USA North now has more manpower to do more educational presentations.

NEW BUSINESS:

3. Short Notice Dig Tickets (Dennis Bott)

There is nothing in Nevada law about short-notice tickets (SNT). There has been a 1700 increase in SNTs dig tickets from 2022-2023. Some excavators use SNTs when they're called in to subcontract an excavation on short notice. The subcontracted excavator is needed for the next day. According to law, each excavator needs their own dig ticket even though the site's already been marked at the request of the originally contracted excavator. Utility owners think of SNTs as emergency tickets. If they get notified of an SNT at 8 pm at night, the utility has to contact the excavator to see if they're digging at 8 pm. The uptick in SNTs seems to be due to soft dig contractors and the growth in usage of vac trucks. Cesar and Dennis would like to create a subcommittee with NUCA and AGC to discuss how to move forward with this issue.

5. Excavator Appreciation Event/Silver Shovel Award (Cesar Castillo)

The south is planning to host this event in April, National Safe Digging Month. The NRCGA also hopes to have a similar event in the north. The NRCGA used to have a Silver Shovel Award recipient in both the north and south, but due to the retirement of the northern NRCGA member who planned the event, it has disappeared for at least a few years. Lynsay Demko has been approved to provide a presentation on the Silver Shovel Award and how to achieve zero damages in a year. at the CGA's annual conference in Colorado Springs, April 14 -18. Scott Allen from Las Vegas Paving, the 2023 Silver Shovel Award winner, will be part of the presentation.

50 IN 5 INITIATIVE:

10. The Plan to Reduce Damages to 50% in 5 Years (Lynsay Demko)
90 ideas were submitted to help Nevada achieve a 50% reduction in damages in 5 years. A third of the ideas fit into the easy to implement category, 1/3 medium, and the last 1/3 were hard. The ideas fit into four categories:
 - **Training**
 - **Regulation**
 - **Locating**
 - **Resources & Communication**

Most of the 90 ideas can be implemented through NRCGA existing committees, but we may need a Regulatory Committee to keep up with new laws introduced/adopted during each legislative session.
