Ticket Management

- Discussion of issues with high ticket volumes, especially from large fiber projects
- Considering ways to educate/regulate ticket sizes and total submissions
- National CGA committee formed to address ticket load leveling
- Need to balance contractor needs with system capacity

Electronic Positive Response System

- New system being implemented to improve communication between excavators and locators
- Allows excavators to dispute responses and request field meets when needed
- Goal is to reduce damages by ensuring clear understanding before excavation begins
- Some concerns raised about potential for abuse; process will be monitored and adjusted as needed

"50 in 5" Initiative Progress

- 11 of 86 submitted ideas formally completed (13%)
 - Key accomplishments:
 - Hands-on bilingual training program implemented
 - Statewide damage flowchart adopted nationally by CGA
 - Focus areas for 2025:
 - Streamlining electronic positive response
 - Field meet requirements
 - Ticket management improvements
 - Increasing vacuum excavation use

Damage Data Reporting

- More comprehensive reporting to CGA's DIRT system needed from all stakeholders
- Current data incomplete, making it difficult to identify trends/issues
- Voluntary, anonymous reporting encouraged by March 15 deadline
- Better data will drive more targeted improvement efforts

Next Steps

- Form committee to review short notice ticket process and data
- Implement new electronic positive response system and monitor results
- Develop education/outreach to landscapers and other non-traditional excavators
- Encourage all stakeholders to report damage data to DIRT system
- Schedule first meeting for new Locator Recognition Award committee
- Transition to new NRCGA chair at next meeting
